WOLDS WAY LAVENDER SEASON PASS 2020

1. Each season pass is specific to each adult/concession/child and is non-transferable.
2. For family groups, you will be issued with 1 card which will include each family member registered with a season pass on the 1 card. If you require separate cards for different members of the same family group, please ask.
3. We require 1 landscape picture including all members of the family group registered to a family card. This can be taken by us on site or emailed to admin@woldswaylavender.co.uk
4. Not all family members have to be present to be able to use a family card, however only individuals with a season pass registered to that card and included in the photo, will be able to use it.
5. Adults: 17-59 years
6. Children: 2-16 years on day of purchase of season pass (under 2 free)
7. Concessions: over 60 years on day of purchase or person with a disability.
8. 1 free carer may accompany a person with disability. This may be a different carer on different visits.
9. Admission and discount is only valid on presentation of a valid card.
10. Season pass cards will be ready to collect from the admissions counter/shop within 1 week. You will still be able to enter/receive 10% tearoom/shop discount whilst your card is being processed – please keep your season pass till receipt to show on entry/at tearoom until you receive your card.
11. Day entry tickets can be upgraded to a season pass (on the day of purchase only). Please ask at shop for details and pricing.

General

1. Not to be used in conjunction with any other offers.
2. Season pass holders receive 10% discount on products purchased in the tearoom and shop. Discount only applies to products purchased for season pass holders.
3. We reserve the right to make any product at any time exempt from the discount scheme.
4. This purchase is for a season pass for the 2020 season (21st March to 27th September 2020 inclusive). For opening times see website.
5. We cannot be held responsible for closures of all or part of our attraction. In the event of any of the above, Wolds Way Lavender will not be liable for any financial loss incurred.
